  - Be fast loading with ease-of-navigation
- 2. Database (as and where required) should preferably be mySQL.
- 3. Server side scripting with PHP

- 4. The site should be bi-lingual (English and Hindi) with seamless navigation
- 5. The site to have search facility and/or exhaustive sitemap
- 6. The menu should be as provided in the current website (https://niced.org.in/) and may be subjected to alteration as per current requirement
- 7. Infographics may be required; details to be provided
- 8. Modular site with scope for addition/modification of menus, sections, modules and pages
- 9. The site to be hosted on NIC server having Linus Web-server
- 10. Site should be Search Engine Optimization (SEO) with Google Analytics preferably enabled
- 11. SSL certification required
- 12. Additional suggestions are welcome
- 13. Use of any third party add-ons, copyright elements, icons and images should be mentioned in the proposal
- 14. The available facilities section should be updated with few recent photographs of the facilities.
