Scope of Work (SoW) – OCR-based Scanning & Digitization of Library Collection at ICMR-NIRBI

1. Nature of Work

The selected agency shall carry out on-site OCR-based scanning and digitization of approximately 30,000 pages of books, reports, manuscripts, and other library holdings of ICMR-NIRBI.

The total number of books to be scanned: _____

- Paper/Soft Bound Books: _____

The work shall include high-quality scanning, OCR processing, digitization, metadata tagging, encryption, and final file delivery in specified formats.

The original books and documents must be preserved in their true physical form without any damage.

2. On-Site Scanning Requirement

- All scanning must be conducted within the premises of ICMR-NIRBI Library.
- No document shall be removed from the premises under any circumstances.
- The vendor shall provide and install their own scanners, OCR software, IT equipment, storage devices, and skilled manpower.
- The agency shall ensure minimum disruption to normal library functioning during the process.

3. Scanning Specifications

- Page Types: Legal, A4, and custom sizes.
- Resolution: Minimum 400 DPI.
- Colour Mode: True Colour (24-bit).
- Output Formats:
 - Master Copy: TIFF/PNG/JPEG (uncompressed).
 - Access Copy: OCR-generated searchable PDF/A.
- File Naming Convention: Must be logical and systematic (e.g., Book_Title_Year_PageNo).

4. OCR & Digitization Requirements

- OCR must support Unicode text recognition for English and regional languages (if present).
- OCR outputs must be searchable, selectable, and indexable.
- Content integrity must be preserved, including text, images, tables, charts, and footnotes.

- Deliverables for each digitized book:
 - One complete PDF/A searchable file with OCR layer.
 - Backup master image files (TIFF/PNG/JPEG).

5. Metadata Requirements

Each digitized document shall include structured metadata, covering at minimum:

- Title of Book/Document.
- Author(s).
- Year of Publication.
- Subject/Keywords.
- Number of Pages.

Metadata shall be submitted in Excel/CSV file format, aligned with file naming convention.

6. Preservation & Handling of Books

- All materials must be handled with utmost care.
- No cutting, tearing, disbinding, or dismantling of books is permitted unless authorized in writing by ICMR-NIRBI.
- Book scanners or flatbed scanners with V-shaped cradles shall be used wherever needed to avoid spine damage.
- The agency shall employ trained staff experienced in archival material handling.

7. Penalty Clause

- Any damage, loss, or defacement of books will invite:
 - Replacement with the same edition (if available).
 - If replacement is not possible: Monetary penalty equivalent to 1.2× the assessed value.
 - Where marked confidential/priority/important: Penalty equivalent to 3× the assessed value.
- Repeated negligence may lead to contract termination and blacklisting.

8. Confidentiality & Data Security

- All scanned/digitized content shall remain the property of ICMR-NIRBI.
- The vendor shall not retain, share, or copy any data post-handover.
- Digitized files must be handed over in encrypted SSDs (2 sets) provided by the vendor.
- A backup encryption key must also be handed over securely.

9. Quality Control & Acceptance

- A pilot batch of 100 pages must be scanned and approved prior to bulk work.
- Digitized outputs will undergo quality checks by ICMR-NIRBI.
- Payments shall be released only after acceptance of work quality and deliverables.

10. Timeline

- The entire digitization of 30,000 pages must be completed within 60 days from the date of Work Order.
- Weekly progress reports must be submitted to the designated officer.

11. Deliverables

- Digitized Files: Searchable PDF/A with OCR.
- Master Images: TIFF/PNG/JPEG.
- Metadata File: Excel/CSV.
- Final Submission: 2 sets of encrypted SSDs (one primary, one backup).

Additional Terms & Conditions (ATC)

1. Equipment Deployment

- The vendor shall provide details of scanners (make, model, resolution capability) to be deployed for the project in the prescribed declaration form (Annexure-I).
- Only approved scanners shall be permitted for use.

2. Manpower Deployment

- The vendor shall submit details of manpower to be deployed, including designation, qualification/experience, and responsibility, in the prescribed format (Annexure-II).
- All manpower must be adequately trained in handling archival/library materials.

3. OCR Software Subscription

- The OCR software used for the project shall be a licensed subscription registered in the name of ICMR-NIRBI.
- The license/subscription, once procured, shall remain the permanent property of ICMR-NIRBI and must not be withdrawn or transferred after completion of work.
- Proof of subscription transfer shall be submitted before initiation of work.

4. Price Break-up
